- 1 If either of the contracting parties fails to fulfill the terms of the contract, the party who fails to fulfill the contract will pay the other party a sum equal to the contest fee stated above unless the contracting parties both agree to waive the payment.
- 2 The official shall not be released from this contract in order to officiate another athletic contest - high school or college - without payment of the damage fee unless mutually agreed to in writing at the time the contract is signed.
- 3 The said school will pay the said official the amount stated above for services rendered, provided that the obligation of the school ceases if and when the official ceases to be an OHSAA Registered official or if the contest is cancelled because of unfavorable weather, epidemics or other emergencies, and the official is notified of such cancellation prior to arrival at contest.
- 4 The obligation of an official ceases if both teams are not present within 30 minutes of the scheduled starting time unless notified that a team will be late. Officials will be paid as per contract.

- 6 Other: The above named official is expressly authorized to bring onto school premises a starter's pistol for the contest as long as the same is used in connection with the event/contest identified herein.

## OFFICIAL'S CERTIFICATE

*As a registered official of the Ohio High School Athletic Association, I acknowledge that when I am employed as an official that I am an independent contractor not an agent. I further agree to be honest in my association with school administrators and the OHSAA and will not be a party to any attempt to establish officiating fees that other officials must follow. I further agree to honor each contract which I sign and will not request a school to void a contract except for illness, injury or a family emergency beyond my control. My conduct on or off the playing surface will be such as to bring credit to myself, the contestants, coaches and the OHSAA. I understand that failure to honor a contract without just cause or violation of the rules of the OHSAA could result in the suspension or termination of my officiating permit.*
